

PUBLIC UTILITY DISTRICT NO. 1 OF FERRY COUNTY

SCHEDULE 100

RESIDENTIAL/SEASONAL

AVAILABILITY:

Available for residential and seasonal service for domestic use qualifying as "Residential Load" as defined in the Pacific Northwest Electric Power Planning and Conservation Act, P.L.96-501. Generally described as all usual residential, apartment, seasonal dwellings and farm electric loads or uses. Any electric use by consumers, which does not so qualify, shall be served under other appropriate rate schedules of the District. Subject to the District's established rules and regulations.

TYPE OF SERVICE

Single phase, sixty cycle, alternating current at 120/240 volts. Multi-phase service may be supplied where the District has facilities available.

MONTHLY RATE:

Basic Charge:	\$20.00 per month single phase service \$61.00 per month three phase service \$20.00 per month single phase seasonal service
Energy Charge:	\$0.08298 per KWH
Minimum Charge:	Basic charge, plus any extension policy requirements

LOW INCOME SENIOR CITIZEN DISCOUNT (LISCD):

Pursuant to RCW 74.38.070, and District Resolution 96-01, low income senior citizens who have completed a qualified application and are 62 years of age or older will be exempt from all but \$3.00 of the monthly residential Basic Charge as outlined above. Requirements, application criteria, and income levels are contained in the above Resolution.

SEASONAL SERVICE:

Seasonal service is made available to those customers who reside within the District's Service area for less than five months per calendar year. Customers taking such service will prepay annually a charge equal to twelve times the above stated monthly Basic Charge. While service may be discontinued mid-year and any unused pre-paid basic charges will be refunded after any electrical usage has been charged. In the event the service is reconnected, a reconnect fee shall be charged and pro-rated basic charges assessed.

SECURITY LIGHTS: (1)

Unmetered

100 Watt	\$ 9.00 per month
250 Watt	\$12.00 per month
400 Watt	\$16.00 per month

Metered

100 Watt	\$ 4.00 per month
250 Watt	\$ 4.00 per month
400 Watt	\$ 4.00 per month

Normal replacement and maintenance of bulbs and control equipment will be made cost free by the District. Repairs necessitated by vandalism will be borne by the consumer.

WHOLESALE POWER COST ADJUSTMENT:

The energy charge component of this rate schedule may be increased to cover any wholesale power cost adjustment levied against the District by its power supplier.

TERM OF PAYMENT:

Electric service accounts are due when rendered and become delinquent on the 15th day of the month following mailing.

- (1) The Security Light Rate under this schedule is intended to apply to the Security Lighting load eligible for exchange under the "Residential Load" definition described in the availability section of this schedule.
