IRRIGATION SERVICE

AVAILABILITY:

Available for service to irrigation pumps, subject to the District's established rules and regulations.

TYPE OF SERVICE:

Three phase, 60 cycle, at available secondary voltages. At the discretion of the District, single phase service may be furnished provided the motor capacity is not in excess of 10 H.P.

RATE:

\$12.00 per connected horsepower All energy - \$0.06152 per KWH

DETERMINATION OF HORSEPOWER:

The District shall determine the connected horsepower by nameplate rating of the motor or at its option by test under conditions or maximum operating load.

MINIMUM ANNUAL CHARGE:

The minimum annual charge for active accounts shall be \$12.00 per horsepower. Provided, however, that for three-phase service, the minimum annual charge shall not be less than \$120.00, and for single-phase service, the minimum annual charge shall not be less than \$60.00.

NON-USAGE DISCONNECT:

A customer may request, in writing, that an irrigation account be disconnected for an entire pumping season.

- Upon receiving this request, the District will establish the account as an "Idle Account" (IRRI).
- To maintain the idle account status, the customer will be billed \$20.00/month Basic charge, regardless of pump size, for the entire 6-month pumping season; a total of \$120.00.
- The idle account may be re-connected upon request of the customer; the customer will then be assessed the standard connect fee when the idle service is re-connected.
- If an idle account is reconnected at any time in the course of the pumping season the customer will also be assessed the full annual horsepower charges for the season. A credit will be given for any idle charges billed during that season to off-set the annual charge

The customer may request the disconnect and removal of all facilities at any time. All charges will be stopped and the facilities will be removed as soon as scheduling permits. Should the customer request re-installation of irrigation facilities, the customer shall bear all costs of such installation.

POWER FACTOR ADJUSTMENT:

The consumer shall maintain unity power factor as nearly as practicable. Horsepower, for billing purposes may be adjusted for consumers with 50 H.P. or more to correct for average power factor lower than 97%, and may be so adjusted for other consumers if and when the District deems necessary. Such adjustments will be made by increasing the horsepower 1% for each 1% by which the average power factor is less than 97%.

TERMS OF PAYMENT AND BILLING:

The minimum annual charge will be billed and payable in five equal monthly installments commencing in May of each year. Annual horsepower charges are due each year the District's facilities remain in place whether or not service is actually used. Kilowatt hour usage will be due in the month billed. In the event the current year's irrigation account, both horsepower and kwh charges, are not paid in full by December 15th, the privilege of paying the annual minimum in installments will be rescinded and the following year's minimum shall be paid in advance before the installation will be reconnected.

GENERAL CONDITIONS:

The irrigation rate does not apply to domestic, stock, or irrigation pumps that are rated smaller than 3 horsepower. Such small pumps will be served under the residential/seasonal rate.

Three-phase motors up to and including 35 horsepower may be installed with standard, "across-the-line", starting controllers. Three-phase motors of 40 horsepower and larger must have reduced voltage starting equipment or permission from the District on an individual basis for across the line starting. The permission will be granted based on system characteristics. The District reserves the right to revoke the permission should the system characteristics warrant.

All 10 horsepower and larger motors must be equipped with overload, low voltage and phase loss protection. It is recommended that overload protection be in each phase of three-phase motors.

Should the pump installations remain idle for the pumping season, and the consumer neglect to pay the minimum charge, the service may be removed. When service is again requested, the consumer shall pay all costs of restoring the installation and sign a new service contract.

PUMPING SEASON:

April 20th through October 20th. Service may be provided off season at the District's residential/seasonal energy rate.

WHOLESALE POWER COST ADJUSTMENT:

The energy charge component of this rate schedule may be increased to cover any wholesale power cost adjustment levied against the District by its power supplier.
