SCHEDULE 400

LARGE POWER SERVICE

AVAILABILITY:

Available for commercial, industrial and other lighting and power uses having an established measured demand of 50 KW or more. Application requirements, once established, may be waived only by action of the Board of Commissioners of the District. Subject to the District's established rules and regulations.

TYPE OF SERVICE:

Sixty-cycle, alternating current, single phase or multi-phase at available primary or secondary voltages. Metered for demand and energy.

MONTHLY RATE:

Basic Charge: Demand minimum billing
Energy Charge: \$0.07063 per KWH
Demand Charge: \$250.00 per month for the first 50 KW or less.
\$ 4.57 per KW for each additional KW up to 105% of Peak Demand
\$ 9.88 per KW over 105% of Peak Demand

Minimum Charge: Demand minimum billing plus any extension policy requirements.

MONTHLY RATE EXCEPTION:

New service accounts, or additional load to existing service accounts, qualifying for this Rate Schedule as defined above, will be charged the monthly rates as detailed, with the exception of demand charges.

Demand Charge: \$250.00 per month for the first 50 KW or less.
\$ 11.42 per KW for each additional KW

This rate will be in effect until the load is established and will remain in effect for an additional 24 month period.

All rate components will be adjusted to cover any wholesale power and/or transmission cost adjustments levied against PUD #1 of Ferry County by its power supplier, or caused by Federal and State Legislative processes. This may include, but is not limited to, any cost recovery adjustment clause or Tier 2 rate charges due to load overage above the District's aMW Retail Load.

PEAK DEMAND

Each Large Power customer's Peak Demand will be calculated bi-annually each October and shall be based on their actual usage for the immediate past twelve consecutive months.

MINIMUM ANNUAL CHARGE FOR SEASONAL SERVICE:

Consumers requiring service only during certain seasons may guarantee a minimum annual charge, in which case there will be no minimum monthly charge. The minimum annual charge shall be sufficient to assure adequate compensation for the facilities installed to serve the consumer. In no event shall it be less than twelve times the minimum monthly demand charge.

DETERMINATION OF BILLING DEMAND:

The billing demand shall be the maximum average kilowatt load used by the consumer for any period of thirty (30) consecutive minutes during the month for which the bill is rendered as indicated or recorded by a demand meter.

WHOLESALE POWER COST ADJUSTMENT:

The energy charge component of this rate schedule may be increased to cover any wholesale power cost adjustment levied against the District by its power supplier.

SECURITY LIGHTS: (1)

Unmetered

100 Watt	\$ 9.00 per month
250 Watt	\$12.00 per month
400 Watt	\$16.00 per month

Metered

100 Watt	\$ 4.00 per month
250 Watt	\$ 4.00 per month
400 Watt	\$ 4.00 per month

Normal replacement and maintenance of bulbs and control equipment will be made cost free by the District. Repairs necessitated by vandalism will be borne by the consumer.

TERMS OF PAYMENT AND LATE PAYMENT CHARGE:

Electric service accounts are due when rendered and become delinquent on the 15th of the month following mailing. A late payment charge of one percent, rounded to the nearest whole dollar, of the total amount past due as of the 20th of each month will be made on accounts receiving service under this rate schedule.

- (1) The Security Light rate under this schedule is intended to apply to the Security Lighting load that is not eligible for Exchange under the "Residential Load" definition described in the Availability section of Schedule 100.
