## **Duties:**

- 3. Work to ensure the District meets all federal, state and other regulatory requirements. Monitor and interpret federal and state regulations, orders and rules to stay informed of current and changing requirements.
- 4. Line extensions, work orders, pole contacts, easements, system design, construction, and environmental compliance.
- 5. Perform other related duties as required.

## Minimum Qualifications, Experience and Certifications:

## **Required:**

- Bachelor's Degree in Engineering, or 10 years of Engineering experience at an electric utility.
- Must possess and maintain a valid WA driver's license.
